Questions to answer for application to Farm'Innov Acceleration Programme

Welcome on the Farm'Innov Acceleration Programme application page. You have a project to renew or accelerate the growth of your business, and you need support to make it happen? Farm'innov can help you secure your project for success.

Who can be accelerated?

As applicant, you must meet the 4 following criteria on the date of application.

- Having more than 25 full-time equivalent employees since January 1st 2023,
- Processing, manufacturing, packaging or distributing agricultural raw materials or food products,
- Generating an annual turnover between 60 million and 800 million Kenyan shillings each year, for the last 3 years
- o Being a company that has been in existence for at least 5 years

The Accelerated Companies Validation Committee will give priority to companies that meet the 4 criteria listed above but reserves the right to select companies that do not meet all the criteria, depending on the number, quality and impact of the projects submitted.

Apart from these 4 criteria, this programme is aimed primarily at senior executives or department managers.

A company may apply only once to the Farm'Innov Acceleration Programme.

Four different parts will have to be filled in in the template: 1. presentation of the company, 2. presentation of the project to accelerate in relation to Farm'innov, 3. challenges encountered and support needs, 4. presentation of the company team applying to benefit directly from the acceleration.

How to apply for the Acceleration Programme?

The call is open from 1st July to 25th August 2024.

The applying company should share its company and project presentations in this online form.

The application must be submitted digitally, via the Farm'Innov project website and only via this channel. The applicant will receive an acknowledgement of receipt once the application has been submitted.

The applicants can apply between 1st July and 25th August 2024.
